


St Ann Catholic Church Financial Report 2023 / 2024 Fiscal Year Year End Report to Parish

Finance Council Purpose and Mission

The Finance Council is an advisory body to the Pastor and the Parish Business Manager in matters pertaining to all financial aspects of the Parish. The Council is responsible for ensuring the parish operates with financial integrity and within its financial resources. The pastor has responsibility for all decisions related to parish activities including financial; however, he shall consider the special responsibilities and skills of the Finance Council as it relates to all financial matters. The Parish Business Manager has responsibility for managing the day-to-day financial operations and budgetary functions. The Council establishes the annual budget, monitors revenues and expenses, and provides recommendations to the Pastor and the Business Manager on all financial matters. The Finance Council meets monthly as part of its responsibilities to complete its mission.

The Finance Council is envisioned as a body of parishioners known for their spiritual maturity and love of Christ and selected based upon competence in financial matters and business acumen, as well as a proven record of prudent judgment. They offer their time and talent as a Christian service to assist the pastor in the development and management of the parish's financial resources so that the parish may effectively pursue its basic mission of spreading Christ's gospel and love. St Ann Catholic Church Financial Report 2023 / 2024 Fiscal Year

Fiscal Year: July 1 thru June 30 each year.

• Cash Flow Position: Since 2018 St. Ann has ended every fiscal year with a positive overall total cash flow. 2023/24 Fiscal year ended with a total operating positive cash flow of \$128,740.



- * Checking Account is used for monthly cash needs, and typically holds approx. 6 weeks of operating capital. Funds within checking account include designated / restricted donations (ie. Food Pantry, GWG, Columbarium, etc.)
- * ** Savings Account includes designated savings for Food Pantry, Capital Building Projects, Columbarium Funds as well as general unrestricted savings. During this fiscal year, we saved an additional \$17,000 net savings since the end of last year. Most notably, we moved \$45,000 into the Food Pantry savings to be used for future Food Pantry needs.

 Audits: The Diocese conducts an independent audit of our financial operations every 2 years. We have received favorable reports on every audit. There have been no findings of any negligence or improprieties. The most recent audit was completed in February, 2024.



St Ann Capital Building Campaigns

- **KOVG: Keep Our Vision Growing:** Initiated in 2017, this fund provides revenues for paying off the Parish Center Loan outlined below. The primary source of donations for this campaign continue to be the 2nd collection that is collected 1 time each month.
- **Growing with Grace:** Initiated in Nov 2023, this campaign will fund expanding the church and parking, as well as other new facilities. As of 7/1/24, we have \$3.1M in pledges and gifts.







Strategic Investments

Over the past few years, the church has made (and continues to make) strategic investments in various ways. Some of these include:

- Youth and Young Adult Ministries
- Community Service: EFAM, Food Pantry, Migrant Ministries, etc.
- New Ministries: Formed, Prayer Groups, Bible Study Groups, Emaus Retreats, Trail Life, etc.
- Staffing to meet the many needs of the parishioners

During 2023/24 we added a new Director of Operations and Business Management, Gerry Confreda. In this position, Gerry is working closely with Fr Peter Grace, staff, and the FC to improve our operations, and communication. One area of focus is bringing better clarity and transparency to the financial operations of the parish. In addition, efforts are being made to establish improved protocols to help improve communications and responsiveness to parishioner needs.

During 2023/24 We welcomed back Carmen Salazar to work with the parish in Development - assisting with raising revenues and improving parishioner relationships. In addition, Lisette Uriostegui joined the staff as the Sacramental Coordinator, and is assisted by Elsa Leon who joined as a full-time assistant to provide better response and coordination for all sacramental services.

 - Growing with Grace Capital Campaign (funding new/expanded facilities.
 - "Living" on campus during construction phases)
- Increasing Offertory and/or Unrestricted donations to maintain operations at existing levels. In 2023/24 we experienced a deficit in unrestricted donations of \$123,812. (We had a surplus of \$252,552 in restricted donations for the same year.)
