RIGHT OF PURCHASE FOR MEMORIAL PLAQUE**

WHEREAS, the Church owns a Columbarium known as the Saint Ann Memorial Garden and Columbarium to memorialize members and their families and for the interment of the cremated remains of members of the Church and their families, and

WHEREAS, the Church has established a set of policies governing eligibility and use of the Memorial Garden and Columbarium, and Purchaser has received a copy and is familiar with the content thereof, and the said policies are attached hereto as exhibit A and are incorporated as if fully set out herein, and Purchaser agrees to future changes in said policies that may be made by the Church.

NOW THEREFORE, in consideration of the sum of \$ \_\_\_\_\_ paid to the Church by Purchaser, the parties covenant and agree with the other as follows. (100% Payment must be made upon submittal of executed Agreement)

1. The Church agrees to provide to Purchaser a Memorial Plaque (as defined in Style 3 of the Policy and Guidelines) within the Memorial Garden with the engraving as identified below, and to provide perpetual care.

- 3. Purchaser authorizes the Church to relocate the memorial plaque to another proper location should it become necessary for any reason, and this authorization shall be binding upon the heirs, executors, administrators and assigns of the Purchaser.
- 4. Purchaser warrants authority to execute this agreement. The Church assumes no responsibility to inquire further into the authority of the person executing this contract.
